Decision – The parish council OBJECT to the above planning application, on the following grounds:-

Such an increase would clearly lead to increased displaced car parking in a cul-de-sac clearly not designed for or able to accommodate further on street car parking.

Increased occupancy levels would also create increased noise and disturbance from the increased comings and goings from the property to the detriment of surrounding council tax paying neighbours, effects that are magnified by the property being at the end of the cul-de-sac and with the rear garden having a number of

boundaries with neighbours.

As with other student let HMOs in the area the over occupancy of properties gives rise to the usual waste disposal issues in terms of storage, presentation for collection etc.

The Parish Council look forward to a prompt and robust refusal of this audacious application.
